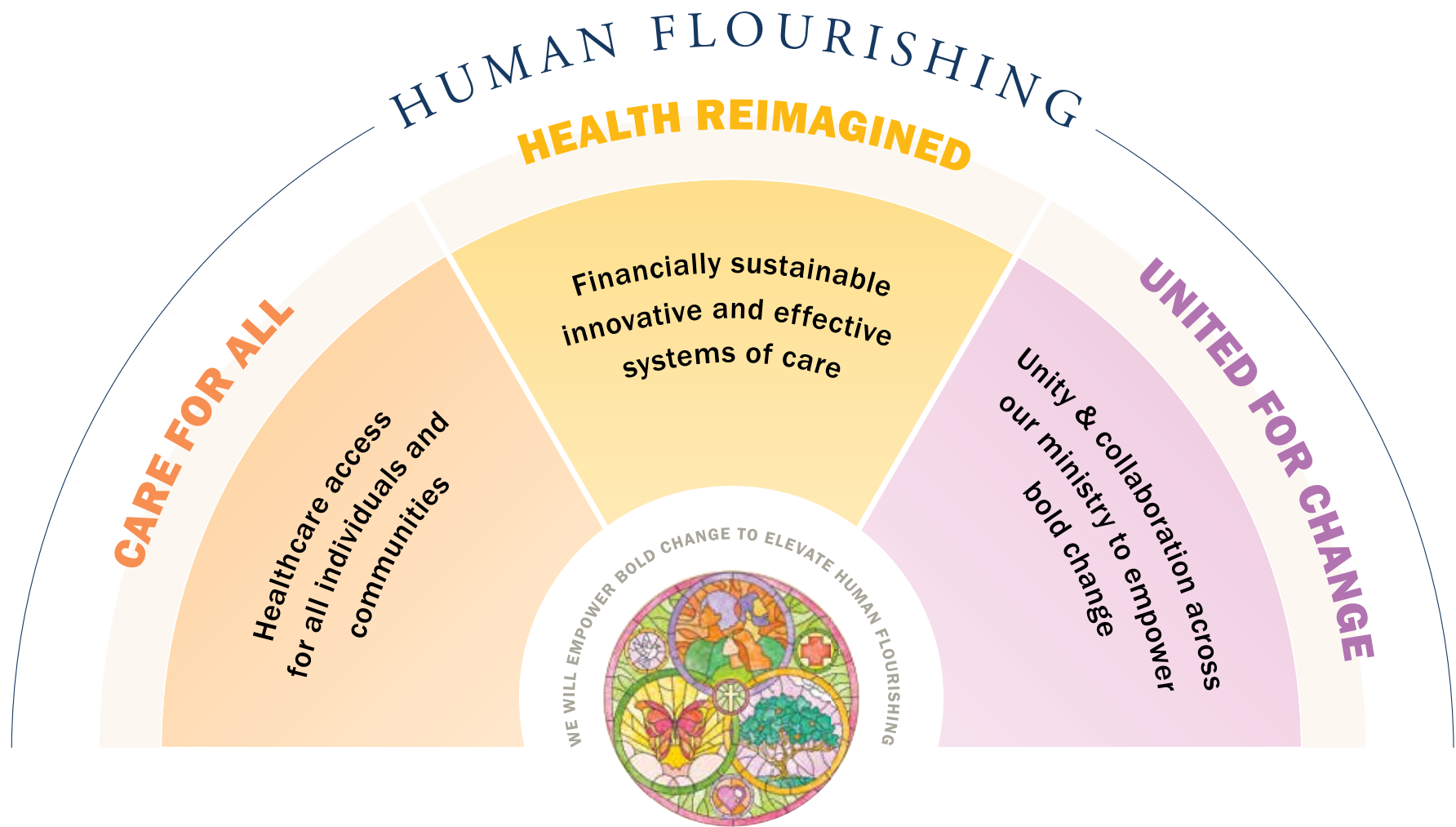




CHA Member Update

Championing Access to Care

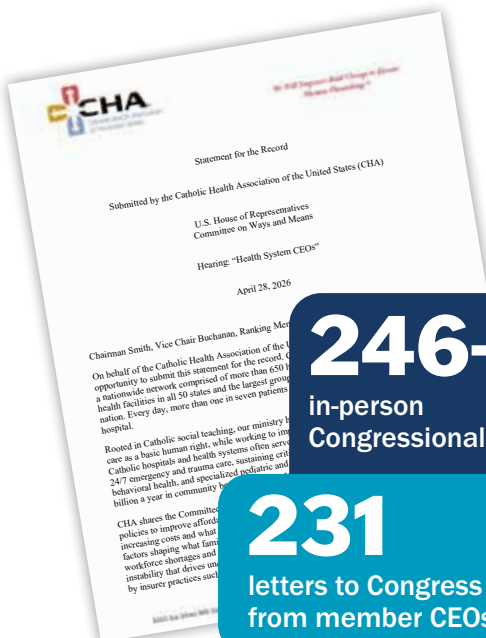
The Catholic Health Association plays a leading role in championing access to care, particularly for those who are underinsured or uninsured. CHA also works closely with its partners in health, community-based organizations, and patient groups to raise awareness and advocate on behalf of those in need.

In FY26, CHA was elected chair of the Partnership for Medicaid, a 25-member coalition of national organizations, thereby enhancing our capacity to advocate effectively for the program. CHA also works closely with Catholic institution partners, such as the United States Conference of Catholic Bishops, Catholic Charities USA, and the Leadership Conference of Women Religious, to push back on policies that undermine Medicaid and harm access to care.

Raising Our Voice for the Vulnerable

CHA continues to advocate on behalf of those most in need through leadership in national coalitions dedicated to supporting local healthcare providers and those most in need. This includes our longstanding partnership with the March of Dimes, which contributed to the passage of the Preventing Maternal Deaths Act Reauthorization, the PREEMIE Reauthorization Act, and sustained momentum for funding critical state maternal and child health programs.

At the same time, CHA has strengthened its leadership within the Patient Quality of Life Coalition to advance policies that improve care for patients with serious illness and to support access to palliative care as a compassionate alternative to physician-assisted suicide.

With the number of people aged 65 and older projected to reach 65 million in 2060 – a 70% increase from 2020 – we have a responsibility to honor the dignity and well-being of a rapidly aging population by ensuring a strong, stable, and compassionate long-term care workforce.

Advancing Community Health

CHA remains the leader in nonprofit hospital community benefit, providing information, tools, and training to assess, plan, report, and comply with community benefit requirements. In FY26, CHA provided a wide array of training and resources, including Community Benefit 101; IRS 990, Schedule H Update; and What Counts and Accounting. CHA has added a hotline and web interface to support professionals in meeting the mission of Catholic healthcare and federal compliance.



GLOBAL HEALTH LEADER

In FY26, CHA expanded its global health leadership through increased member participation and high-impact engagement with global partners and Church leadership.

These included:

- ❖ Vatican-hosted convenings in Rome on universal access to healthcare, and Water, Sanitation and Hygiene (WASH) in healthcare facilities.
- ❖ WHO, World Bank and the World Health Assembly
- ❖ Bishops' conferences in low- and middle-income countries
- ❖ World Telehealth Initiative

MINISTRY IDENTITY ASSESSMENT

The Ministry Identity Assessment (MIA) is one of the ministry's most important tools for sustaining, measuring, and advancing Catholic identity in a rapidly changing environment. To date, 14 representative systems have completed

58 assessments. Members are using MIA findings in board reports, sponsor conversations, and dialogue with bishops, grounding discussions of Catholic identity in shared, data-informed insights.

CATHOLIC SOCIAL TRADITION

A new resource, *Let Dignity and Justice Flourish*, further supports the work of ministry formation through video-based resources with guides and materials that help leaders engage and apply Catholic social teaching.



MISSION INTEGRATION

Mission Services supports Catholic healthcare ministries through consultation, formation, and collaborative dialogue, while promoting best practices and research. Through webinars, in-person programs, and other resources, CHA equips leaders to steward mission, values, and Catholic identity, continuing Jesus' healing work.

FORMATION AND LEADERSHIP DEVELOPMENT

- ❖ In January, CHA's **Foundations of Catholic Healthcare Leadership Program** provided leaders with a grounding in core theological and ethical principles through an eight-week virtual experience, drawing participants from 25 member organizations. Since its inception, thousands of Catholic health leaders have participated in the Foundations program.
- ❖ **The Sponsor Formation Program for Catholic Healthcare** prepares individuals to serve as current and future members of juridic persons, equipping them to advance the Church's healing ministry. Since 2014, more than 200 leaders have completed the 18-month program; the 2026 sixth cohort includes 50 participants from 18 member ministries.
- ❖ CHA engaged more than 1,300 registrants through this year's nine-session **Emerging Topics in Catholic Healthcare Ethics** series, reflecting strong interest in addressing complex, contemporary ethical challenges.

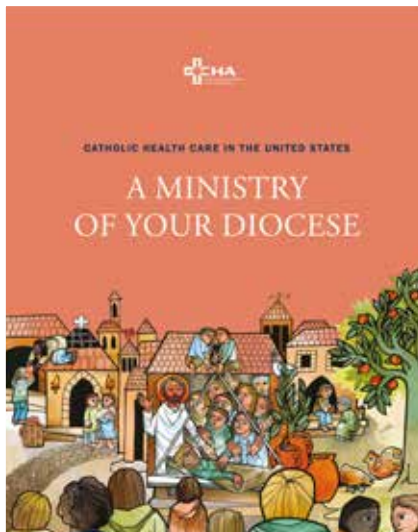
Strengthening Ecclesial Relations

A UNIFIED VOICE

CHA continues one-on-one conversations with bishops in dioceses with Catholic health ministries. These conversations focus on Catholic identity, future leadership and sponsor formation, and how a unified Catholic healthcare voice can support the redesign of the U.S. health system.

CHA developed a new resource, *Catholic Healthcare in the United States: A Ministry of Your Diocese*, designed to help bishops more easily understand the role, scope, and ecclesial significance of Catholic healthcare in their dioceses.

ERD REVISION

CHA worked closely with USCCB staff, bishops, system ethicists, and ministry leaders throughout the revision of the *Ethical and Religious Directives for Catholic Healthcare Services* to ensure that the lived realities of Catholic healthcare informed the Seventh Edition while remaining fully grounded in Church teaching. This collaborative process itself strengthened ecclesial relationships and unity across the ministry. Since promulgation, CHA has focused on education and implementation, offering targeted webinars, educational modules, and interpretive resources for clinicians, ethicists, and ethics committees.



A 'TRANSFORMATIONAL' EXPERIENCE

At CHA's *Ecclesiology and Spiritual Renewal Program* in Rome and Assisi, 32 leaders participated in an immersive formation experience focused on the Church's global mission and Catholic healthcare's core commitments. The program consists of formational experiences, meetings with Church leaders, and communal prayer and reflection. Many reported renewed commitment to mission, stronger grounding in Catholic identity, and lasting impact on their leadership, describing the experience as "transformational." This program is in its 26th year.

The Center for Theology and Ethics in Catholic Health

OUR MISSION

The Center for Theology and Ethics in Catholic Health (CTECH) is dedicated to creating the space, time, and forum to delve into issues that impact CHA members. The Center offers faithful guidance that leaders and clinicians in Catholic health and the Church can apply in their ministries.

During FY26, the Center issued position papers, hosted webinars and events, and produced a monthly podcast that collectively provided a more thorough understanding of the theological, moral, and social teachings of the Church, particularly as they relate to the delivery of healthcare.



AI THOUGHT LEADERSHIP

In March 2026, the Center hosted a conference at Boston College where more than 150 leaders from the Catholic Church, healthcare, public policy, and academia convened to explore the ethical dimensions of artificial intelligence.

In response to Pope Leo's encyclical *Magnifica Humanitas*, the Center has been actively engaged in the public square, providing fresh insights and perspectives on the promises and perils of AI.



Pope Leo XIV's *Magnifica Humanitas* invites readers to reflect on how AI can both contribute to and threaten human flourishing. The pope surfaces important moral values and personal and social realities that the human community considers as it discerns the role of AI in society.

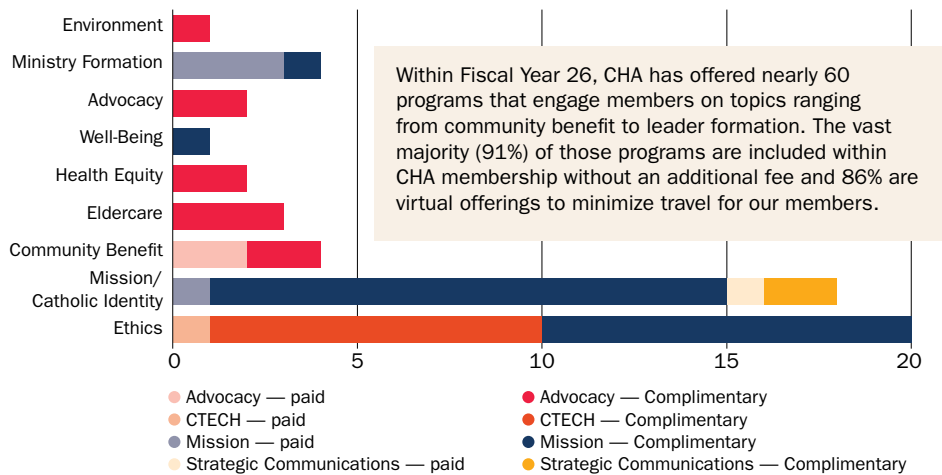


Engaging Our Members

PROGRAM TOPICS BY AREA

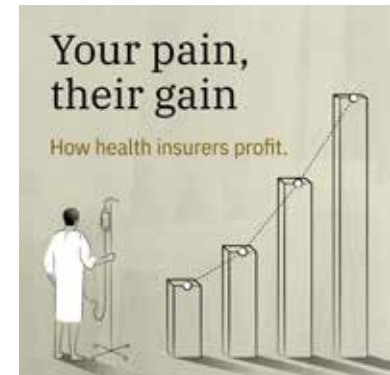
