Dear Chair Murray, Ranking Member Blunt, Chair DeLauro, and Ranking Member Cole:

As organizations dedicated to improving the health of all women, children, and families, we strongly urge you to support at least **\$750 million** for the Title V Maternal and Child Health (MCH) Services Block Grant in the **FY2022 Labor, Health and Human Services, Education & Related Agencies Appropriations bill**.

The Title V MCH Block Grant is a cost-effective, accountable, and flexible funding source used to address the most critical, pressing, and unique needs of maternal and child health populations in each state, territory, and jurisdiction of the United States. While programming varies among states and territories, all of them are working to promote health equity and reduce disparities in access and care experienced most acutely by Black, Tribal, Indigenous and other people of color. According to data gathered by the Health Resources and Services Administration (HRSA), ***92% of all pregnant women, 98% of infants, and 60% of children nationwide benefitted from a Title V-supported service in FY2019.***

States and jurisdictions use the Title V MCH Block Grant to design and implement a wide range of statewide and community-level maternal and child health programs to fit the needs of their specific populations. These programs save federal and state governments money by ensuring that people receive preventive services to avoid more-costly chronic conditions later in life. Title V programs are at the forefront of addressing maternal mortality and morbidity, working to identify causes of pregnancy-associated deaths and severe complications, devising plans to address those causes, and implementing programs to prevent future deaths and near misses. Title V MCH Block Grant programs also work diligently to train the next generation of maternal and child health workforce leaders as well as address emerging issues and public health emergencies that impact maternal and child health.

During the past year, Title V-funded programs have been at the forefront of COVID-19 response efforts with a particular focus on addressing the unique impacts of the pandemic on maternal and child health populations. The flexible nature of the Title V MCH Block Grant has made it an easily deployable source of support for states to meet locally identified needs and foster positive maternal and child health outcomes

during the public health emergency. States have utilized Title V MCH Block Grant funding during the COVID-19 pandemic to operate hotlines, conduct case investigations and contact tracing, and support public education about the pandemic. Additional innovations in providing maternal and child health services during the COVID-19 pandemic have included purchasing blood pressure cuffs for virtual monitoring of pregnant patients; conducting virtual safe sleep classes; and distributing safe sleep spaces like portable cribs and other newborn essentials like diapers without person-to-person contact. The Title V MCH Block Grant is well-positioned to continue addressing maternal and child health needs during the COVID-19 pandemic, but the program needs additional funding to do so effectively.

Further gaps that can be filled via Title V programs include: supporting transition to telehealth services; ensuring equitable access to universal COVID-19 testing of pregnant patients; offering virtual childbirth, breastfeeding, and parenting classes; conducting communications campaigns around child abuse prevention and the importance of continuing routine maternal and childhood immunization; assuring timeliness of screening and follow-up for heritable disorders and newborn hearing; providing critical information to pregnant women, new mothers, and their families; and ensuring access to medication and equipment for children with special health care needs and respite care for their families, among other activities.

We thank you for funding the Title V MCH Block Grant at \$712.7 million in FY2021 and **urge you to provide an increase to at least \$750 million in FY2022 for both the state formula fund and discretionary portions of the block grant** to meet the increased demands being placed on the Block Grant.
