## **Action Alert: Sharing Your Community Benefit Story with Congress**

Congress is adjourned for an extended break in August. This provides an opportunity for Catholic health providers to reach out to their elected officials and staff and let them know about the vital role their hospital plays in improving health in our local communities. CHA continues to stress these points in meetings with members of Congress in the face of sustained attacks on nonprofit hospitals in Washington and elsewhere.

If possible, invite your members of Congress to tour your health facilities and see for themselves the difference you are making in their communities. CHA also encourages you to share your Community Health Needs Assessment and its implementation strategy with your members of Congress, as well as any additional information you can provide about the activities your systems and facilities are doing to help meet those needs. CHA is <u>providing a resource</u> to help guide your discussions about community benefit with elected officials featuring commonly asked questions.

#### **Protect What's Precious Medicaid Toolkit**

States are currently in the process of reviewing eligibility determinations in the Medicaid program. CHA is working to ensure that enrollees in Medicaid and the Children's Health Insurance Program (CHIP) coverage do not lose their vital health insurance coverage. CHA's resource, the <a href="Protect What's Precious Toolkit">Protect What's Precious Toolkit</a>, provides the ministry with tools and knowledge to help eligible Medicaid and CHIP beneficiaries maintain their coverage. This toolkit includes talking points for front-line staff, posters, flyers and CCTV resources.

Assessing Reality in Healthcare Financial Information | HFMA (April 2023)
This whitepaper highlights differences in reporting between IRS Form 990
Schedule H, the Medicare cost report, and financial statements using generally accepted accounting principles (GAAP). Communicating these differences and how these various data sources should be used is becoming increasingly

important as this information is being used by policymakers, researchers and the media to evaluate hospital community benefit efforts.

Embracing Creative Tensions To Advance Health Equity | HealthAffairs (June 2023). This article highlights five key creative tensions or paradoxes that need to be leveraged effectively to address health disparities. It includes case studies and key practices to advance health equity.

Hospital Service Offerings Still Differ Substantially By Ownership Type | Health Affairs (March 2022). Access to care impacts how well and how long we live. "Nonprofit, for-profit, and government hospitals are all more likely to offer services when they are relatively profitable than when they are relatively unprofitable. However, for-profit hospitals are considerably more likely than others to provide services based on profitability." This article looks at service offerings across hospital ownership type.

American Hospital Association's <u>Community Health Assessment Toolkit</u> was recently updated with an intentional focus of health equity within all aspects of the assessment.

NACCHO's <u>Mobilizing for Action through Planning and Partnerships (MAPP) 2.0</u> toolkit was released at NACCHO's annual meeting in Denver this July. This community-driven process in developing a community health needs assessment

and implementation plan focuses on achieving health equity.

The Root Cause Coalition launched their <u>Equity Legislation Monitor</u>. This tool highlights policies that address social determinants of health along eight priority areas: digital equity; diversity, equity, inclusion, and justice; environment and climate change; gun violence prevention; housing; maternal health; nutrition and food security; rural health and payment models.
