# Resources for Integrated Care: Promising Practices For Utilizing Motivational Interviewing To Improve Care Coordination And Address Social Determinants of Health

The Resources for Integrated Care project held a webinar on Aug. 17 called "Promising Practices for Utilizing Motivational Interviewing to Improve Care Coordination and Address Social Determinants of Health (SDOH)." The session was supported through the Medicare-Medicaid Coordination Office within the Centers for Medicare & Medicaid Services and aimed to support providers in care integration and coordination for dual eligibles. The session included an overview of motivational interviewing and tips on including it in screening for gaps in social determinants of health, as well as a panel discussion around promising practices.

## Johns Hopkins Bloomberg School of Public Health: What is the Black Maternal Health Crisis and How Can it Be Solved?

Black women are two to three times more likely to die from pregnancy-related complications than white women. They are more likely to experience life-threatening conditions like preeclampsia, postpartum hemorrhage, and blood clots, as well as increased incidence of other pregnancy-related complications like preterm birth and low birth weight. This podcast discusses the crisis and multiple solutions, including reforming policy, health systems and medical education and bolstering community-based organizations that advocate for better care and resources for Black moms.

#### Rise to Health: A National Coalition for Equity in Health Care

The American Medical Association (AMA) and the Institute for Healthcare Improvement (IHI) have launched Rise to Health: A National Coalition for Equity in Health Care, aiming to create a more equitable health care system where everyone has the power, circumstances and resources to achieve optimal health. While discussing the partnership's goals, the AMA President said ending systemic racism in health care will end health inequity for everyone, and the IHI President and CEO noted that quality improvement drives health equity. Rise to Health Coalition seeks to create a more equitable system by training health care providers, changing mindsets within health care, and influencing policy, payment and education through four key impact areas: access, workforce, social drivers of health, and quality and safety.

## Heath Affairs: Residential Segregation and Health: History, Harms, and Next Steps

This issue brief outlines the history and cause of residential segregation, how it disproportionately harms neighborhoods of color, and how future research can prove a causal relationship between residential and racial segregation and poor health outcomes. In the United States, residential racial segregation is a fundamental structural determinant of health. This brief examines racially discriminatory public and private policies designed to exclude non-white households from resources afforded to white households dating back to at least the Great Depression. These policies restricted non-white households' access to neighborhoods with greater resources and fewer environmental hazards, reducing access to educational opportunities, household income and household wealth.

## The Commonwealth Fund: How Pediatric Care Providers Are Identifying and Addressing the Impacts of Racism on Children

For Black families living in poverty, taking a child to a hospital can be a frightening experience. Too often, hospital staff conflate being poor with neglect, resulting in reports to child welfare authorities that can lead to a traumatizing investigation and, sometimes, even foster care placement. Black parents are more likely than white parents to be suspected of and reported for child abuse. In contrast, Black patients and their visitors are more likely to have hospital security called on them when a conflict arises. This issue brief examines how hospital staff are being trained to recognize and respond to discriminatory conduct, how security practices are being redesigned, and how families are being given more time to discuss their concerns with providers.

The main learning objectives include understanding the importance of cultural competence in health and nutrition programs, exploring best practices for engaging Asian American and Pacific Islander communities in a manner that takes cultural beliefs into account, and developing an implementable

## U.S. Department of Health and Human Services Office of Climate Change and Health Equity: June Climate and Health Outlook

The U.S. Department of Health and Human Services (HHS) Office of Climate Change and Health Equity (OCCHE) recently shared its next edition of the Climate and Health Outlook. This is a public information series connecting weather forecasts to health resources to inform health professionals and the public on how climate events may affect their health and provide resources to take action. The Outlook shares data to educate the public and save lives by reducing illness and health risks associated with climate-related hazards such as wildfires, hurricanes, droughts and vector-borne diseases that impact human health. This edition focuses on the prevalence and health risks of extreme heat events across the country and provides a forecast into the impact of the 2023 hurricane season.
