

Sponsor Formation Program for Catholic Health Care 2026 – 2027

CHA's Sponsor Formation Program for Catholic Health Care prepares individuals for service as members of Juridic Persons to carry out the health ministry of the Catholic Church.

In addition to a rich grounding in the theological and canonical principles that apply to all sponsorship models, CHA's formation program offers participants opportunities for spiritual development personally and as members of a community who share a deep commitment to advance Jesus' healing mission in the world today.

The program consists of four two-day sessions in the fall and spring. Gatherings focus on developing and enhancing critical competencies for sponsorship through a combination of reflection, participant involvement, group interaction, and presentations by nationally recognized ministry leaders and speakers. In addition, preparatory and follow-up materials allow for additional learning integration. In the time between sessions, participants will meet with assigned Conversation Partners and in groups of fellow participants to reflect on their learnings and make appropriate application for their spiritual development and work in the Catholic health ministry.

Overview

OBJECTIVE

In order to form individuals to serve in the role of sponsor, this program will enable participants to articulate, integrate and implement the foundational elements of Catholic health care sponsorship.

LOCATION

The program takes place at the Eaglewood Resort & Spa in the Chicago area, conveniently located near the Chicago O'Hare Airport.

FORMAT

The program consists of a series of four in-person sessions in the fall and spring. Each session begins on Wednesday afternoon and concludes on Friday morning. Each session will be complimented with a virtual session to deepen the participants' experience.

Gatherings focus on developing and enhancing critical competencies for sponsorship through a combination of reflection, participant involvement, group interaction and presentations by nationally recognized ministry leaders and speakers. In addition, preparatory and follow up materials allow for additional learning integration.

CRITERIA FOR PARTICIPATION

Participants in CHA's Sponsor
Formation Program for Catholic Health
Care are selected by a sponsoring
organization that is a member of
the Catholic Health Association.
Enrollment is limited to foster
meaningful opportunities for reflection,
interaction, networking and learning
integration. Current sponsors and
persons deemed to have demonstrated
potential for possible service as a
sponsor receive priority consideration.
Other leaders of Catholic health
ministries who interface with sponsors
will also be considered for the program.

EXPENSES

The registration fee for the 2026–2027 program is \$6,000 per participant. The fee includes all program-related costs, hotel accommodations and meals associated with the sessions. Transportation is not included

Curriculum & Timeframe

The curriculum weaves biblical, theological, and spiritual aspects of sponsorship ministry into a model that incorporates adult learning methods within a framework of ministry formation. Participants are expected to fully engage in a formational experience that enables them to articulate and integrate the foundational elements of Catholic health care sponsorship.

Orientation Session

FEBRUARY 11 or 17, 2026

THEME: FOUNDATIONS OF SPONSORSHIP

An online session will orient participants to the basic foundations of the ministry of sponsorship. Participants will engage with interactive content introducing the key components of sponsorship.

During the session participants will discuss:

- → Sponsorship defined
- + Origins of Catholic health care sponsorship
- The sponsor responsibilities



Session One

MARCH 18 - 20, 2026

THEME: THE CALL TO SERVE

- + Called to serve in the Church and Catholic health care
- ★ Exploring spirituality
- → Sponsorship history, theology, and development

Participants will be invited to reflect on sponsorship as a vocation to serve in the Church.

At the end of this session, participants will be able to:

- Articulate the meaning of vocation and identify how their vocation is a call to serve within the Church.
- Understand the meaning, development, and core responsibilities of sponsorship of Catholic health care.
- Appreciate the importance of spirituality and spiritual practices.
- Appreciate the call to serve in the name of the Church as custodians of Catholic identity.

Session Two

OCTOBER 7 - 9, 2026

THEME: TO SERVE WITHIN THE CHURCH

- → Mission and the prophetic tradition of the Church
- → Spirituality and community
- → Canon law, sponsorship and health care

Participants will explore the Church's prophetic tradition and the fundamental aspects of canon law related to the ministry of sponsorship.

At the end of this session, participants will be able to:

- Continue to understand the meaning and purpose of the Church.
- Appreciate the prophetic role of the sponsor in the Church.
- Recognize the underlying principles of community.
- Understand essential aspects of canon law as applied to sponsorship.



Session Three

MARCH 17 - 19, 2027

THEME: LIVING OUR TRADITION

- → Discernment
- → Catholic Social Tradition.
- Ethical and Religious Directives for Catholic Health Care Services

Participants will be invited to reflect on sponsorship as a vocation to serve in the Church.

At the end of this session, participants will be able to:

- Understand the history and principles of the Catholic Social Tradition in the context of the Catholic health ministry.
- Recognize the underlying principles of a spirituality of discernment and its application to communal decision-making.
- Understand the format and purpose of the *Ethical and Religious Directives for Catholic Health Care Services* (ERDs) and their impact on the sponsor's role.

Session Four

OCTOBER 6 - 8, 2027

THEME: COMPANIONS ON THE JOURNEY

- ★ Emerging issues in Catholic health care
- ★ Ecclesial relations and sponsorship
- ★ Formation as a life-long journey

Participants will explore the emerging issues facing Catholic healthcare and why ecclesial relations are essential to the sponsor ministry.

At the end of this session, participants will be able to:

- Identify current issues in U.S. health care and their impact on the Catholic health ministry.
- Appreciate the essential relationship between the sponsor and the Church.
- Understand the essential role of the laity in the ministry of sponsorship.
- Appreciate the importance of a commitment to ongoing formation for sponsorship.
