


The Legal Imperative

The Community Benefit Standard – Revenue Ruling 69-545

- Community board
- Open medical staff
- Emergency room open to all regardless of ability to pay
- Hospital otherwise admits patients able to pay, either themselves or through insurance, Medicare or Medicaid
- Excess funds applied to facilities, patient care, medical training, education and research

- Community health needs assessment
- Implementation strategies
- Financial assistance policies
- Billing, collections, charges

- Expand on earlier answers
- Define community and explain how needs are assessed
- Describe what else the organization does for its community
- Opportunity to describe the story behind the numbers

The Legal Imperative

The Affordable Care Act Requirements for Tax-Exempt Hospitals

- Adopt financial assistance policy
- Limit patient charges
- Limit collection practices
- Conduct a community health needs assessment
- Adopt an implementation strategy

What Is Community Benefit?

Program or activities that provide treatment or promote health as a <u>response to community needs</u> and meet at least one community benefit objective:

- Improve access to health services
- Enhance public health
- Advance knowledge
- Relieve government burden




Community Need

Community need can be demonstrated through:

- Community health needs assessments
- Request from public agency or community group
- Partnership with government or other tax-exempt organizations
