From 2006-2009, Hill was the Indiana Deputy Health Commissioner serving in the Administration of Governor Mitch Daniels.

Hill earned a Bachelor of Science degree in Nursing from the University of Cincinnati, a Master of Arts in Health Care Mission from Aquinas Institute of Theology, and a Juris Doctorate from Indiana University School of Law at Indianapolis.

She currently serves as an Adjunct Professor with Aquinas Institute of Theology teaching Health Care Ethics, and is a member of Catholic Health Association's Theologian/Ethicist Committee.

Hill is proud to continue her experiences at Avera, citing one reason being that it is the largest womenowned organization and employer in South Dakota. "I look forward to continuing the promotion of Avera's mission and Catholic identity at all levels of the organization by influencing policy and strategic decision-making," she said.
