Previously, Strauss led Summa Health System for 15 years, during which time Summa experienced significant growth in market share and financial revenues, and earned the NorthCoast 99 award for best workplaces in Northeast Ohio for 11 straight years. His extensive experience also includes leadership roles for Meridia Health System, Baxter Health Care Corporation and Allegheny General Hospital.
