

Healthy Heart Self-Monitoring Blood Pressure Program

- 16-week program supporting SMBP, and heart health education and coaching by FCNs.
- Care offered to individuals where they are and by trusted messengers, addressing barriers such as transportation, housing instability and access to care.

Goals included:

- Increase faith community, individual, and care provider engagement in BP management.
- Increase the number of people who can accurately take their own BP.
- Decrease the number of people with uncontrolled BP.

Outcomes:

Overall decrease in both systolic and diastolic BPs during the 16-week program.




Collective Impact
